VIC: And that's all

Snell: Okay now I'm gonna ask you some questions and when you um left Arizona did you leave your home voluntarily?

VIC: No my step father had kicked me out of the home

Snell: Okay and the people who brought you here to Arkansas

VIC: Mhm

Snell: Do you know their names?

VIC: Yeah Jarvis McWright and Carolyn Denny her nick name is Coco

Snell: Okay and where did you know them from?

VIC: They were in Arizona during the time I was in Arizona

Snell: Okay how long had you known them before you left Arizona?

VIC: I had not known them at all so I just met them that same day that day taking me

Snell: Okay and when you left Arizona and you mentioned that was around the 11th or so of October correct?

VIC: Yes

Snell: Okay where was your intention to go?

VIC : I didn't really know where to go cause I was kicked out of my house and I was frozen so I didn't know where to go

Snell: Okay but where when you met up with these two folks

VIC Mhm

Snell: Alright where were where were you planning on going at that time?

VIC I was didn't want to be in Arizona anymore cause I didn't feel wanted due to the fact of my stepfather kicked me out and told me that I'm not allowed to come back home again

Snell: Mhm

VIC : So any other city or state I don't

Snell: Okay what were you told what were you told as to where you were going at that time?

VIC The couple told me that they had some family business they had to take care of in Tennessee

Snell: Mhm

VIC : And so they told me that I would be able to come with them and so we're on our way there but we were passing through Arkansas and we had stayed in a house here in Arkansas that was one of Jarvis's brothers he called his brother but I'm not sure if it's his blood brother but it was a trap house that he us stay in with his children

Snell: Okay and where in what town do you know where that house is?

VIC : West Memphis

Snell: In West Memphis

VIC Yes

Snell: Okay and how long did it take you to travel from Arizona to West Memphis?

VIC Three days

Snell: Okay and you were with this couple the whole time?

VIC · Yes

Snell: Okay when you arrived in West Memphis do you know where this trap house was you were staying at?

Snell: It's in the middle of town I don't remember the address cause it didn't have an address on it

Snell: Mhm

vic I just kind of sorta remember what the house looks like but I don't remember the way there

Snell: Okay and who else stayed there?

vic Jarvis's brother, Reggie and his girlfriend and there me, Jarvis, Coco and their kids

Snell: Okay at the time you were staying there were you free to come and go?

vic Not really

Snell: How were you prevented or how were you not free to come and go?

vic Um the boyfriend kept driving off to sell drugs and things like that and we wouldn't left with any vehicle so we stayed in the house and he wouldn't come back until hours later had passed and gone by

Snell: Alright

vic He kept the car

Snell: Were you restricted from walking away?

vic Yeah cause the neighborhood the house was in was a bad neighborhood

Snell: Okay how do you know that?

vic I seen a lot of people with guns and there was acts of violence going on in the neighborhood. I had seen a lot of police

Snell: Okay and how long were you at that house?

vic Only for two days

Snell: Okay and then what happened to you after that two days?

vic Well during those two days the boyfriend Jarvis McWright started sexually touching me and in my sleep and restraining and holding me down I couldn't get up out of bed. So the second day I had told his girlfriend what he was doing to me and they got into a fight about it and she had driven me over to her friend's house her mutual friends, which is Victoria McClure and Ricky Gaines

Snell: Okay so she knew Victoria McClure?

vic Yeah

Snell: Okay had you Victoria McClure or Ricky Gaines prior to that time?

vic Um since we drove in over there yes

Snell: Okay and so the she drove you to over to

VIC We had taken a taxi

Snell: Okay and where was that?

VIC That was in West Memphis 220 West Oliver Street

Snell: Okay and how long were you at 220 West Oliver?

VIC I was there for almost four months now

Snell: Okay since October?

VIC Yeah

Snell: Okay and who else was there at West Oliver?

VIC It was just Ricky, Victoria and then me then he had an uncle living with him but he had left the house and so it was just us three

Snell: Okay and where did stay while you were at the house?

VIC Um

Snell: Describe where you slept

VIC I slept on the couch

Snell: And were you left alone at the house at any time?

VIC Yes a couple of times when Victoria and Ricky would leave wouldn't tell me where they were going what they were doing

Snell: Mhm

VIC And they would leave me for like a couple of days and hardly in food

Snell: Alright were you free to leave?

VIC I was free to leave somedays but on other occasions I wasn't free

Snell: Okay in what way were you restricted?

VIC I was restricted in a back room cause Ricky had started getting physically aggressive and abusive towards me and sexually assaulting me

Snell: Okay and while you were there okay and you were there for a couple of months

VIC Yes

Snell: At least right?

VIC Mhm

Snell: Um what what happened to you while you were there as far as you know on a daily basis or a frequent basis?

VIC He would Ricky would tell me and Victoria we had a couple things Ricky wouldn't tell me what we were doing so this was all new to me. We would end up going to an attorney's office. She would pretend that we're getting something for Ricky's probation come to find out it's for hustling and so there was a lot of sexual interaction that was going on

Snell: Okay let's

VIC Okay

Snell: Let's take this a little bit at a time

VIC Okay

Snell: Alright how long had you been at Oliver at the house in Oliver okay before the first incident of you being taken somewhere?

VIC two or three weeks

Snell: Two or three weeks?

VIC Yes

Snell: Okay and who took you out of the house and took you somewhere?

VIC Victoria McClure

Snell: Okay and how did she take you?

VIC By taxi

Snell: Okay and on that first occasion where did you go?

VIC To an attorney's office

Snell: Okay and where was that do you know where that attorneys off was?

VIC : Yes it was by a courthouse in West Memphis in one of these back buildings off to the side of the courthouse

Snell: Okay

VIC By the train tracks
